You will also be receiving periodical E-shots once there will be important news related to the Programme.




1. 110 APPLICATIONS RECEIVED

110 applications were submitted during the 1st Call for Proposals, which ended on the 2nd of April, 2010. The total sum of the EU funding requested by these applications slightly exceeds 55 million euro.

68 applications were submitted under Priority 1 (measure 1.1-20, 1.2-3, 1.3-1, 1.4-23, 1.5-21) and 42 applications under Priority 2 (measure 2.1-16, 2.2-20,




The champion region what regards the number of applications submitted is Vilnius County (Lithuania). 48 applications were submitted by beneficiaries coming from this region. 23 applications came from Latgale region (Latvia), 15 – from Alytus County (Lithuania), 7 – from Utena County (Lithuania), 6 – from Kaunas County (Lithuania), 3 – from the territories outside Programme area (Latvia), and 2 – from Panevėžys County (Lithuania), Grodno, Vitebsk Oblasts and Minsk (Belarus). No applications were submitted from Mogilev Oblast (Belarus).



In comparison to other programmes


In comparison to other cross-border cooperation programmes of the European Neighbourhood and Partnership Instrument, the result of our Programme ranks around the middle, yet it is rather high if proportion of Programme area and number of applications is considered:

Next call

The 2nd Call for Proposals should be launched in the autumn of 2010. Before the opening of the call, the Joint Technical Secretariat of the Programme will organise the 2nd trilateral partner search forum, where potential applicants from Latvia, Lithuania and Belarus will be able to find partners. Please follow the information on our Programme website. The subscribers will receive the news regularly.



2.PROPHET OF THE PROGRAMME IS...

In the 2nd issue of "Our story", we invited you to guess how many applications would be submitted during the 1st Call for Proposals. We promised to call the person, who would guess right the Prophet of the Programme.

3. PROCEDURE OF EVALUATION OF APPLICATIONS



The Opening session of the applications, submitted for the 1st Call for Proposals, during which the application envelopes were opened was organised on the 26th of April.

The provisional evaluation and selection schedule is planned as follows:

- **1.** By the end of May all the applicants should receive letters informing them about the results of the administrative check. Before that, some of the applicants may receive the letters asking them to submit certain clarifications. Please, check your post/fax regularly in order not to miss the deadlines set for submitting the clarifications.
- 2. By the end of June the letters informing about the results of the eligibility check should

follow. These letters will be sent only to the applicants of the action proposals, which have passed the administrative check. Again, you might be asked for some clarifications during the eligibility check.

- **3.** The decisions on projects to be approved or rejected shall be made by the Joint Monitoring Committee, based on the quality assessment results and proposal of the Project Selection Committee, which is provisionally scheduled for September.
- **4.** By middle of October the applicants, whose proposals have passed the eligibility check, should be informed about the final decision regarding the EU funding.
- **5.** Finally, the applicants of the projects approved for funding will have 3 months to submit the technical documentation for construction works, if relevant, and 6 months to get the approval of their action by the Government of the Republic of Belarus. After this procedure will be finalised, the applicants will sign the Grant Contracts and become beneficiaries.

4. COMMUNICATION HANDBOOK FOR ACTION IMPLEMENTERS

The Joint Technical Secretariat has prepared the Communication Handbook for Action Implementers. Feel free to use it when preparing your applications in the future or while implementing the actions.

5. EUROPE DAY COMES

The traditional Europe Day will be celebrated in many European countries on the 9th of May. This day commemorates the fact that on the 9th of May, 1950 the then foreign minister of France Robert Schuman announced his declaration calling for united Europe and laying down the fundaments for what we know today as the European Union. The Schuman Declaration provisioned the establishment of the European Coal and Steel Community, which became the 1st European Community, later followed by the European Economic Community and Euratom.

- The main celebration of the Europe Day in Lithuania will take place in Druskininkai on the 8th of May (organised by the Representation of the European Commission in Lithuania).
- In Latvia the main celebration week of Europe (from the 5th to the 9th of May) will take place in Riga.
- In Belarus, two actions related to the EU will be organised in May: the festival of the EU films (starting on the 10th of May) and the competition for journalists writing about the EU (since the 14th of May). For more information, please contact the EU Delegation to Belarus.

- to make the EU's international aid more efficient.
